Local Service Tax Self-Employment Return Instructions

Local Services Tax (LST) is payable by all individuals who hold a job or profession within the Cumberland County taxing jurisdiction. The CCTB jurisdiction includes all of Cumberland County, the West Shore School District and municipalities in Northern York County and the Shippensburg Area School District and municipalities in Eastern Franklin County. Employers withhold and remit Local Services Tax for their employees. For those individuals who are self-employed the liability to remit is their responsibility. All self-employed Individuals must use their work location within the Cumberland County taxing jurisdiction to complete their self-employed local services tax return. Using the official tax register website http://munstatspa.dced.state.pa.us/FindLocalTax.aspx?T=1 input your work location and click find municipality. This will provide you with the name of the political subdivision in which you work. Using the chart below, find your Political Subdivision to determine the PSD number and the total amount of LST due for the year.

If the combined rate of an LST exceeds \$10, the tax should be prorated and paid by self-employed individuals on a quarterly basis. If the rate is \$10, the self-employed individual may pay their tax in a lump sum payment. Self-employed taxpayers shall pay the tax 30 days after the end of each calendar quarter.

Payments not received 30 days after the end of each calendar quarter are subject to penalty and interest. Penalty is due 10% of the tax due of each quarter the tax remains unpaid. Interest is due .000017 of the tax due x # days the tax remains unpaid.
